Professional curiosity learning from review sessions for Frontline practitioners and managers from across the adults and children's multi-agency workforce

the aim of the sessions are to set out the meaning and importance of Professional Curiosity; highlighting learning from local Child Safeguarding Practice Reviews and Safeguarding Adult Reviews; and sharing resources available to support practitioners. By the end of the training participants will understand what it means to be professionally curious, learn from local reviews to understand the barriers to professional curiosity, be confident to exercise professional curiosity in a respectful manner and know where to find strategies to support professional curiosity.

Mothers Union Exhibition To highlight 'hidden issue' of Domestic Abuse, The Mothers' Union (MU) branch for Blackburn Diocese is organising a 'powerful and moving' new exhibition to bring the often hidden issue of domestic abuse into the light. This year, Blackburn Diocese MU organised

their new Exhibition, entitled 'The Souls of our Shoes', at Lancaster Priory from September 11-28. National News

The UK Government has announced that the Online Safety Act has now received Royal Assent putting rules to make the internet safer in the UK into law. The Act initiates Ofcom's new powers and places legal responsibility on tech companies to prevent and remove illegal content and stop children seeing harmful content. UK children and adults to be safer online as world-leading bill becomes law

The Internet Watch Foundation (IWF) has published a report on artificial intelligence (AI) generated child sexual abuse material (CSAM) online. Research Report: IWF research into how artificial intelligence (AI) is increasingly being used to create child sexual abuse imagery online

The Department for Education (DfE) has published new statistics on children in need in England for the year ending 31 March 2023. Children in need

This guidance is primarily aimed at frontline staff who work with children, young people and vulnerable adults and explains the nature of this harm to enable practitioners to recognise its signs and respond appropriately so that victims and potential victims get the protection and support they need.

A new briefing draws on evidence from research and practice to describe what Transitional Safeguarding is and why it is needed. It's aimed at health professionals involved in safeguarding children and young adults accessing healthcare and is also useful for those who provide care or support to their family members or carers.

Transitional Safeguarding | Research in Practice

The BBC has published a news story on the placement of homeless 16 and 17-year-olds in hostel accommodation. It features concerns from Coram Voice around provision of support for teenagers and explains that most 16 or 17-year-old children who are accepted as homeless by a local authority should be taken into care under section 20 of the Children Act. Homeless teens 'tricked away from care by councils to save money'

The Consortium of Voluntary Adoption Agencies (CVAA) have created a guide on adopting siblings. The guide shares the experience of families who have adopted siblings and provides information on sibling dynamics and support networks. CVAA launches new advice guide for people considering adopting siblings

The Prison and Probation Service and healthcare staff are about to review their caseloads across England for prisoners who should be released early on compassionate grounds, usually prisoners in palliative care. This could increase requests for social care planning and support for these prisoners over the coming month. More details in this briefing.

National Safeguarding Adults Week

This year the week of awareness will be 20th - 24th November. This week will focus on supporting you - as the workforce, including safeguarding roles, having a trauma informed approach and providing support for the carers.
